Proposed project

Overall explanation: The MedUP! aims to support social enterprises to grow or scale up. For this purpose it provides grants to support projects by SEs that enable growth or scaling.

specifically and directly related to the implementation of the project. The value of the in-kind contribution must be tangible and verifiable, based on specific supporting evidence such as contracts, invoices and others.
